

Government of Pakistan has received a Joan (Credit No 6243-PK) from the International Development Association (IDA) for funding of Panjah Cities Program (PCP) and intends to use part of the funds to cover eligible payments under the contract for sub-projects comprising of Improvement and Rehabilitation of Roads & Chowks in Vehan City. The Program will be implemented under the control of Panjah Municipal Development Fund Company (PMDFC)

The Municipal Committee Vehari invites sealed hids from eligible hidders on who can prove their eligibility and qualification as mentioned in the Bidding Documents for the works and have not been Black Listed by any Government agency/department/organization/donor etc. The Bidding is open to all Eligible Bidders.

Bidding process of works mentioned below shall be carried out in accordance with Punjab PPRA Rules 2014 and revised procedures thereon.

Basic Eligibility: The Employer invites sealed bids under PPRA Rule 382(4) Single Stage-Two Envelope (SSTE) bidding procedure from eligible Constructor/firms or persons licensed by the Pakistan Engineering Council in categories as mentioned below.

Bidding/Tender documents issuance. Bidder may obtain, immediately the bidding documents from the address mentional below during office working hours upon payment of an amount of 2s. 10,000° (Non-refundable) in cash oil 08-04-2023 during office hours. Bid must be accomparied with 2% of the Estimated Cost of scheme as Bid Security in stage of CDR/Bink DruftPay Order in the name of Municipal Committee, Vehandrom a Scheduled Bank of Pakistan and must be attached with Technical Bid. If the Bid Security is not found attached with the technical bid or amount of bid security is less than given amount, the bid will not be considered for evaluation and will be rejected straight forwardly. Opening of bids: The Technical Proposal and Financial Proposal will be enveloped separately by marking in bold and legible letters to avoid confusion and both are then placed in a single envelope. Technical bids will be opened on the same day i.e. 10.04.2023 at 11:00 AM in the office of Municipal Officer Infrastructure, Municipal Committee Vebari by the Precurement Committee in the presence of Bidders or their Authorized Representatives who choose to attend as specified in the bidding document. The Financial proposal of technical qualified bidders will be opened subsequently.

Financial Bids are required to be submitted on Item rate basis (not on the basis of MRS with percentage premium) and the rates and amounts must be filled by the bidder for each item in the Bill of Quantities and quote the total price.

If the bid amount of successful bidder is seriously unbalance in relation to the Detailed Estimate, the bidder shell have to furnish additional Performance Security equal to the difference of Estimates Cost and the total bid amount in the shape of Bank Guzrantee duly issued by any Scheduled Bank of Pakistan as per satisfaction of the Employer besides furnishing detailed price analysis to demonstrate internation consistency of his prates as per Clause IB 28.4 of bidding document.

The pre bid meeting with bidders and their authorize representatives will be beld on 03-04-1023 at 11:00 AM in the office of Chief Officer, Municipal Committee Vehan to clarify the issues and to answers any question on matters related to bid documents.
